Dear Ms. Dillon and Mr. Bolger,

The California Regional Water Quality Control Board, Los Angeles Region (Regional Water Board) is the public agency with primary responsibility for protection of ground and surface water for all beneficial uses within Los Angeles and Ventura counties. As such, we are the lead agency for overseeing corrective actions and cleanup of releases from leaking underground storage tank (UST) systems at the subject facility (Site). We have completed our review and evaluation of the information provided to this agency for the UST release(s) at the Site and determined that this case meets the Regional Water Board's low threat criteria for a case closure.

Pursuant to California Health and Safety Code Section 25296.20(a) and Division 7 of the Porter Cologne Water Quality Control Act, and State Water Resources Control Board Resolution 2012-0016, the Regional Water Board is required to notify any and all interested parties (water authority or district, building permit agencies, owners and occupants of the properties impacted by the petroleum release, or adjacent properties) as defined in Resolution 2012-0016 prior to considering corrective actions or granting case closure. You have been identified as the interested water company (City of Lomita) and a fee title holder (County of Los Angeles) for the Site. We hereby notify you of our

plan to close this low threat UST case. To expedite the review and approval process, we request that you provide us with any comments on the proposed plan to close this case in writing to [jamesw.ryan@waterboards.ca.gov](mailto:jamesw.ryan@waterboards.ca.gov) by **February 22, 2022**. If you do not wish to participate, you need not respond. If we do not receive a written response by **February 22, 2022**, the case will be closed, and you will be notified of our decision.
