The California Regional Water Quality Control Board, Los Angeles Region (Regional Board) staff received the letter “Hi-Shear’s Request for a 60-day extension of the Public Comment Period for the Cleanup and Abatement Order” (Letter), dated December 22, 2020, submitted on Hi-Shear Corporation’s (Hi-Shear) behalf by Hamrick & Evans, LLP, for the above referenced site (Site). The Letter requests a 60-day extension of the public comment period for the draft Cleanup and Abatement Order No. R4-20XX-XXXX (Draft CAO).

Subsequently, the Regional Board received an email dated December 29, 2020 (Email) from Mr. Tom Schmidt of Hamrick & Evans, LLP on Hi-Shear’s behalf. The Email revised the extension request to a 14-day extension for the submittal of comments to the Draft CAO. The initial due date for the written comments and/or evidence regarding the Draft CAO is 5:00 p.m. January 4, 2021 as required in the Regional Board’s November 30, 2020 letter.

The Email provided the following reason for the extension request:

- Due to the comment period occurring over the Christmas and New Year holiday period, additional time is needed to prepare and submit the comments to the Draft CAO.

After reviewing the request, the Regional Board partially approves the extension request. Written comments and/or evidence regarding the Draft CAO are now due to the Regional Board by **5:00 p.m. January 11, 2021**.
